- **Applied exercise:** simulate T+2 vs real-time settlement with a cyber-fraud scenario.
- **Workshop:** draft a Treasury Innovation Roadmap (AI + Digital + Cyber).
- **Closing session:** positioning treasury as a digital-age enabler of value.
